# CAMPIG PARK OF FOZ DE ALGE

INTERN REGULATION

SEASON:	ALL YEAR
WORK HOUR RECEPTION:	From 08h00am to 08h00pm
SILENCE HOUR:	From 11h00pm to 07h00am

The campsites are for the practice of camping and caravanning in the form of vacation, end-of-week camping or traveling, the conditions laid down in the Regulation.

The camper always keeps the most perfect cleanliness of the place where it is installed and the neighboring land, collaborating in the task that everyone competes in defense of the environment.

## **CHAPTER I - ADMISSION AND REGISTRATION**

- 1. The reception will be open to qualified personnel at least from 09:00 to 19:00.
- A day use park is considered to INPUT / CHECK IN to be made from 12:00 and OUT / CHECK OUT to be made up to a maximum of 12 hours the next day.
- It can not be denied attendance in the campsites campers national and foreign, getting the same dependent on the following:
  - a. NACIONAL

Prior identification, upon presentation of the letter of camper, camper letter of youth passed by body officially recognized, or Identity Card / Citizen Card.

b. FOREIGN

Preliminary identification, upon presentation of the International Camping Carnet or respective passport;

- c. NATIONAL RESIDENT ABROAD
- The same treatment of the preceding paragraph, if it proves do.
- 4. Minors under 15 years can only attend the park when accompanied by parents or guardians accountable for longer than they.
- 5. According to the law, all users are required to process your application indicating the particulars and documents of their identification, and well as the days and hours of their arrivals and departures. The documents shall be deposited at the reception during their stay in the park.
- Whenever campers constitute a group, simply subscribe to one element of this group, presenting, however, identification documents of all elements of the group.

## CHAPER II – VISITS

- 1. Visits are authorized to users installed in the park, and when presented to the input received by them and must leave at the reception identification after settlement of fees due.
- 2. The period of stay is strictly set between 09:00 and 22:00, and can not use their vehicle inside the park.
- Visitors are required to comply with the rules and disciplines campers are responsible for it and the campers visited.

## **CHAPER III – BAN THE PARK**

- 1. It prohibits the presence in the park to people who are suffering from diseases or who otherwise could impair both health park.
- 2. It prohibits the presence in the park to people who are accompanied by animals, not living with vaccination card duly notarized.
- 3. If any user of the park addresses a complaint originating from noise or poor hygiene caused by animals and this is substantiated, will be the user responsibility to withdraw the animal from the campsite.

## **CHAPER IV – RIGHTS OF USERS**

- 1. Use their facilities in accordance with the provisions of this Regulation and Dec. 38/80.
- 2. Knowing in advance the prices in the park.
- 3. Require the passage of bills relating to expenses payable.
- 4. Require submission of the complaints book, even in the case of expulsion from the park.
- 5. Require submission of the regulation of the park.

6. Keep inviolate their accommodation, namely preventing the entry therein and opening your windows or doors.

7. It is up to parents to prevent children practice efforts or acts that endanger their health or in any manner likely to disturb the well-being of any user.

8. Users who have a complaint should state your full name, permanent address and identification document, otherwise one can not be considered.

## **CHAPER V – DUTIES OF USERS**

1. Accept, within the park, the authority of those responsible for its operation.

2. Fulfill the precepts of hygiene adopted in the park, especially those pertaining to the fate of waste and dirty water, washing and drying clothes, admission of animals and prevention of infectious diseases.

3. Install your equipment so as to keep the distance of 1.5 meters to the equipment of other campers, unless otherwise agreed.

4. Refrain from any action likely to disturb other users, namely to make noise between 23:00 and 07:00 hours and use during the same period, broadcasting equipment.

5. Do not fire except in such places to meet and for the other fire protection measures in place in the park.

6. Comply signaling park guards and indications regarding the parking of vehicles.

7. Do not put people in the park without authorization from the appropriate charge.

8. Leave the park at the end of the period previously established for the stay, since the capacity is exhausted and there is need to satisfy previously confirmed reservations.

9. Paying the price of services used, according to tabelassem force.

10. Having regard to the observance of the rules of hygiene, morality, public order and coexistence.

11. Refrain from using language, vocabulary and acts that depart from the norms of politeness and civility principles that should form the identity card of every camper and every citizen.

12. Refrain from using clothing that is not in accordance with the ethical camper or constitutes a manifestation of social discrimination.

STILL SHOULD REFRAIN FROM:

a) To destroy or damage trees or other plants.

b) Transpose the existing fences in the park.

c) Play with balls, rackets, etc.., outside places designated for this purpose.

d) Build constraints around the tents, caravans or the kitchens, with spies, strings, stones, pine cones, shells, hanging beds, swings or other.

e) Use wire or putting ropes, wires, etc.., height less than 2 meters from the ground.

- f) Leave abandoned during the night lamps, stoves and lamps lit by the danger that it is.
- g) Leave the faucets open or compete in any way for damage pipelines or other facilities.
- h) Use the fountains for purposes other than the water supply.
- i) Planting or seeding without authorization of the charge of the park.
- j) Wash clothing or extend outside the places designed for that purpose.
- k) Make commercial advertising, political or religious.
- I) make subscriptions or any public collection without permission of the head of the park.

m) Posting any writing or drawing without permission of the park responsible.

n) Make use of firearms, air pressure and other.

a) Leave the dirty game where was installed.

p) Install kitchens apart more than a meter from their tents (wall to wall). Can only use fire to cook the existing location in the park for the purpose.

q) use of unreasonable improvisations with crates of furniture, boards, bricks, stones, etc.., as well as any other out-ethics camper.

r) Maintain sleeping bags, blankets, etc.., extended outside the tents or caravans, after 11 hours.

s) Maintain mounted overnight beds suspension.

## **CHAPER VI – VEHICLES**

1. Circulation is not allowed inside the park except to enter or exit the same;

2. It is not allowed to flow bicycle unless authorized in times or places duly marked for this purpose;

3. All vehicles that are not registered and are found within the park, after discharge period, pay to stay since admission of its owner in the park;

4. Not the right vehicle parking along the area camping, being able to assign you another place when necessary for installation of units campers;

5. All vehicles already registered in reception and arriving after 23 hours, parking outside the control of entry, are still subject to a fee;

6. Do not exceed the speed of 10 km / h;

7. Not make adjustments or repairs without parental consent in the park;

8. It is not allowed to wash out the appropriate location;

9. It is not permitted to make use of sound signals;

10. It is not allowed to park in order to prevent the free movement or installation of material.

## **CHAPER VII – SANCTIONS**

1. Failure to meet the standards of administration or application, as well as disrespect of the remaining provisions of this regulation will lead to penalties of up to abandonment compulsive park. In the latter case, the identification of camper will be seized. During his arrest and even higher decision shall be denied the right frequency of the park to the wearer offender.

May be requested the intervention of the police authority to enforce these determinations, according to the Decree n. 9 38/80 of 19 August.

2. The park is in charge of the Board of FPCC (Portuguese Federation of Camping and Caravanning), with regard to compliance with this regulation.

3. In cases not provided, the park officials settle taking into account the principles set out in this Regulation and Regulatory Decree n. 9 38/80, with the appeal to the Directorate General of Tourism.

4. Those in charge of the park will decline any liability including investigation and identification of perpetrators of accidents, damage or theft of users.

5. The responsibility for these acts should be imputed to its author or authors if it is smaller.

## CHAPER VIII – POWER SUPPLY

1. The electrical sockets are only consented when meet the security conditions in coated cable, legitimately and its passage will always be by air.

2. Faults in the wiring of the field, caused by the poor state of the material of the campers, are your responsibility.

3. It is not allowed to supply power to advanced trailer.

## CHAPER IX – MISCELLANEOUS PROVISIONS

1. The use of sanitary pads is subject to the separation of the sexes.

2. When is distributed any identification, campers will present it whenever it is asked for.

3. It is mandatory to display in a conspicuous place of the documents that are distributed to visitors identification and units, which must be returned at the time of abandonment of the park.

4. All objects found must be delivered at the reception of the park.

5. The charge of the park is not obliged to call users on the phone unless they are urgent communications or notice.

6. Users can use the hotel pool, having to pay the entrance fee. Before entering will have to go to reception to make the registry entry.

7. The organization of the park campimos inform its users in IN / CHECK IN parties to organize periods of 15 days, and these days the time for silence / rest of the park will be extended until 02.00 am.

8. Complaints and alvitres will be recorded in their respective books that will be made available to users on request.
